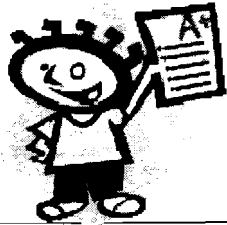
Math Coach Mrs. Rutledge explained Florida Standards. Teachers will move from lecturing to getting students to think critically. Math, English/Language Arts standards.
